## Association Agreement

I hereby apply for REALTOR® Membership in the West and SouthEast REALTORS® of the Valley (WeSERV). I understand that my dues and the application fee are nonrefundable. I agree to attend orientation and the National Association of REALTORS® (NAR) Code of Ethics training within 90 days of my application for REALTOR® membership. Failure to meet these requirements may result in having my membership suspended, with an additional reinstatement fee of \$95.00 assessed and due upon completion of the requirements.

I agree to thoroughly familiarize myself with and abide by the SEVRAR, AAR, and NAR Bylaws, the WeSERV Policy Manual, and the NAR Constitution. I will abide by the Code of Ethics and Arbitration Manual as amended, including the obligation to arbitrate controversies arising out of a real estate transaction as specified by Article 17 of the Code of Ethics.

I understand I have access to a copy of the WeSERV, AAR, and NAR bylaws, the WeSERV Policy Manual, the NAR Constitution and Code of Ethics. I understand that I will be required to complete periodic Code of Ethics trainings as specified in the association's bylaws as a continued condition of membership. I authorize WeSERV and any of its representatives to verify the information I have provided herein.

The remaining 30% is provided to National PAC and is charged against your limits under 2 U.S.C. 441a.
